#### Application requirements

The following application requirements apply to an application under Clause 43.01, in addition to those specified elsewhere in the planning scheme and must accompany an application, as appropriate, to the satisfaction of the responsible authority:

- Site, elevation and floor plans that are fully dimensioned and scaled showing:
  - Existing conditions.
  - The extent of any proposed demolition, alterations and additions and new (replacement) development.
  - The location and setback of adjoining buildings.
- Oblique view diagrams taken from the opposite side of the street, at 1.7 metres from ground level.
- Photomontages of the streetscape showing the proposed development.
- A written report from a suitably qualified person that includes:
  - An assessment of the impact the proposed building, works, demolition, tree removal, landscaping and subdivision may have on the significance of the heritage place.
  - Photographs of any significant heritage fabric proposed to be demolished.
- A Conservation Management Plan prepared in accordance with the principles of *The Burra Charter - The Australian ICOMOS Charter for Places of Cultural Significance* (Incorporated International Council on Monuments and Sites, 2013) for applications for major alterations and additions to individually significant places
